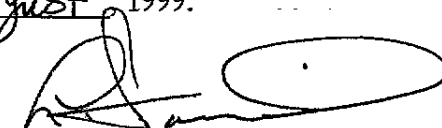
ARTICLE VII

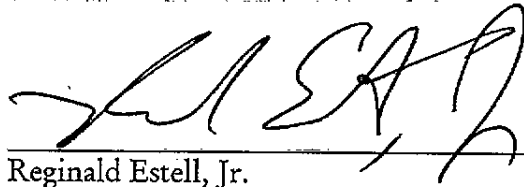

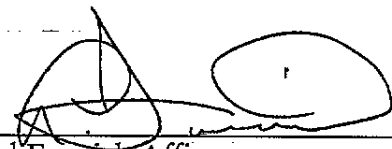

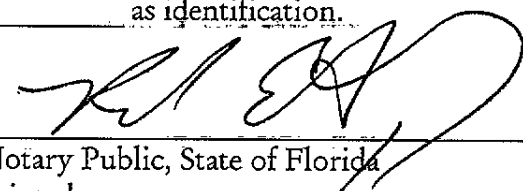
