ARTICLES OF ORGANIZATION OF PRESGAR IMAGING, L.C.

The undersigned, acting as a member of the captioned limited liability company under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), hereby files the following Articles of Organization:

ARTICLE I Name

The name of the limited liability company PresGar Imaging, L.C. (the "Company").

ARTICLE II Period of Duration

The Company shall commence its existence on July 14, 1999 and thereafter shall remain in existence until such time as the occurrence of any dissolving event defined in the Company's Regulations.
