ARTICLES OF ORGANIZATION

OF

LIGHTSPEED SIGNAL, LLC, A Florida Limited Liability Company

ARTICLE I

NAME

The name of this limited liability company is: LIGHTSPEED SIGNAL, LLC.

ARTICLE II

DURATION

The maximum period of duration of this limited liability company shall be 51 years from the date of this filing with the Department of State or December 31, 2050, whichever is earlier.

ARTICLE III

PURPOSE

The purpose of this limited liability company shall be to manage video communications resources and to conduct any and all other business permitted by the laws of the State of Florida.

ARTICLE IV

d) There is no additional capital contribution required or agreed to other than as set forth in (c) above.


e) There are rights given to members to admit additional members.


