**ARTICLES OF ORGANIZATION
OF
GRIES ENTERTAINMENT PRODUCTIONS, LLC**

The undersigned, as an authorized representative of a member of the Company, pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida limited liability company named **GRIES ENTERTAINMENT PRODUCTIONS, LLC**.

ARTICLE I

Name

The name of this limited liability company shall be **GRIES ENTERTAINMENT PRODUCTIONS, LLC** (the "Company").

ARTICLE II

Address

The mailing address and street address of the principal office of the Company is: 2620 Parkview Avenue, Tampa, Florida 33629.

ARTICLE III

Duration

The period of duration for the Company shall be perpetual.

ARTICLE IV

Initial Registered Office and Agent

ARTICLE V

Right to Admit Additional Members

The managing members may permit the admission of Additional Members and determine the Capital Contributions of such Members upon a majority vote of the managing members.

Right of Continuation


