The same in scope as before the termination of continued membership of such member.

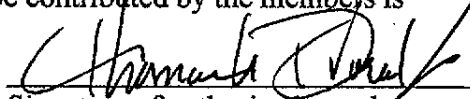

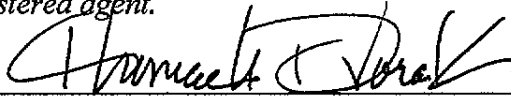
