ARTICLE I.

In regards to day-to-day matters, each manager will have the capacity of managing the affairs of the corporation without requiring any other consent. Checks of all kind shall require the signature of one manager, and one manager may enter into any contract, agreement, etc., and so bind this company, in the day-to-day affairs of this company. Nevertheless, to sell or mortgage real estate of the company, the signature of the two managers will be required; similarly, in the sale of all of the assets - or substantially all of the assets- of this company, the signature of the two managers shall be required.

No person or institution, including, financial institutions, will be required to look beyond this Article in regard to the faculties granted by it.

ARTICLE VIII.

This limited liability company shall have all the powers granted to limited liability companies by Section 608.404 of the Florida Statutes, as presently enacted and any other powers that may be given by Florida Statutes, in addition to the foregoing, from time to time.

ARTICLE IX.

The interest of the members in this limited liability company may be evidenced by certificate or certificates of limited liabilities company's interest issued by the company and signed by two managers of the company.

ARTICLE X.

Any remaining member or members of this limited liability company have the right to continue the business of the company in case of bankruptcy, expulsion, dissolution, resignation, retirement, and if the member is an individual, death, or of any other event which terminates the continued membership of a member in this limited liability company. A simple majority of the remaining members should be sufficient to exercise this right. If only one member remains, the consent of such member shall suffice. This company may admit additional member or members provided that a majority of the then members of the company agree to such additional member or members.






