**ARTICLES OF ORGANIZATION
OF
PUBLIC FINANCIALS, LLC**

ARTICLE I - Name

The name of the Limited Liability Company is PUBLIC FINANCIALS, LLC (the "Company").

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 4840 S.W. 64th Place, Miami, Florida 33155.

ARTICLE III - Duration

The period of duration for the limited liability company shall be perpetual.

ARTICLE IV - Management

The Company will be managed by its managing members (the "Managers"). The Managers shall be elected annually by the members in the manner prescribed by and provided for in the Operating Agreement of the Company. The Managers shall also hold the offices and have responsibilities accorded to them by the members and as set forth in the Regulations of the Company. The name and address of the initial Manager who is to serve until the first annual meeting of the members or until his successor is otherwise selected is as follows:

ARTICLE V - Admission of Additional Members

The right, if given, of the remaining members to admit additional members and the terms and condition of the admissions shall be subject to a vote of two-thirds of the existing members and conditioned on the new member's agreement to abide by all existing agreements of the members regarding the conduct of the Company.

ARTICLE VI - Members Rights to Continue Business

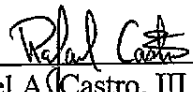
The right, if given, of the remaining members of the Company to continue the business in the event of the termination of the Company due to death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining or surviving members may continue in the business of the Company provided that not less than a majority of the ownership interests agree to do so in writing.

ARTICLE VII - Registered Agent and Office

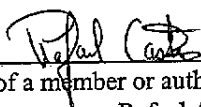
