These amendments to the Articles of Organization are to be recognized effective as of the initial filing date of the Company with the State of Florida on August, 16, 1999.

**AMENDMENTS TO THE

Article IV – Management

The Company is to be managed by a single Managing-Member, Juan C. Castro (the "Managing-Member"), and shall be managed as prescribed by him at his sole discretion in accordance with statutes, laws and regulations of the State of Florida that enables such corporate governance as a single Managing-Member. The Managing-Member is to carry out the functions and responsibilities of his office and meet the terms and provisions of the Operating Agreement. The Managing-Member shall hold offices and have responsibilities accorded to him as set forth in the Regulations of the Company. The Managing-Member of the Company will serve in such office perpetually or until his death. The complete name of the Managing-Member of the Company is:

Article V – Admission of Additional Members

The right to admission of additional members in the Company is prohibited. The Company is structured to enable the Managing-Member to serve the Company in his own capacity with no additional membership participants.

Article VI – Members Rights to Continue Business

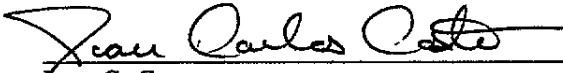
The right to continue the business of the Company in the event of termination of the Managing-Member due to death, retirement, resignation, expulsion, bankruptcy, dissolution, or any other occurrence is to be resolved according to the estate decree of the Managing-Member.

Article VII – Registered Agent and Office

The street address of the organization's initial registered office is 4840 SW 64th Place, City of Miami, County of Dade, State of Florida, 33155, and the name of the authorized registered agent at such office is Juan C. Castro.

Acceptance of Appointment of Registered Agent
