The Limited Liability Company's existence shall commence upon the filing of these Articles of Organization with the Florida Department of State.


Article 10. Regulations


2. I declare that the above named Limited Liability Company has at least one Member.

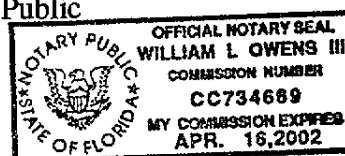
