ARTICLES OF ORGANIZATION
FOURTH STREET VENTURE I, L.L.C.

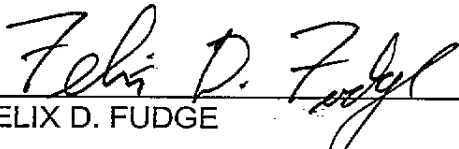
