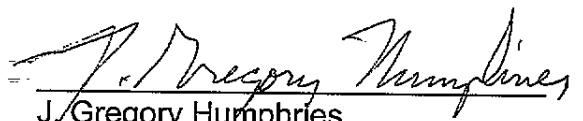
ARTICLE V - Registered Agent and Office

ARTICLE VI - Miscellaneous

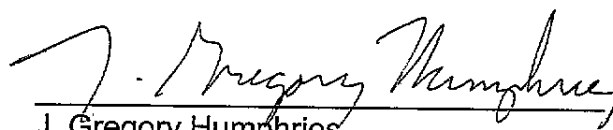
