ARTICLE VIII


REGULATIONS OF THE COMPANY





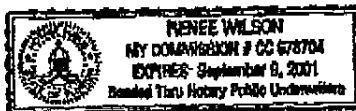
