# ARTICLES OF ORGANIZATION

NORTHWOOD COMMUNITY CARE, L.L.C., a Florida Limited Liability Company

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, hereby adopt the following Articles of Organization for such Company:

# ARTICLE I

# NAME

The name of the Company is NORTHWOOD COMMUNITY CARE, L.L.C.

# ARTICLE II

# DURATION

The existence of the Company shall commence as of 9:00 a.m., E.S.T., on August 25, 1999, and shall continue for a period of thirty (30) years from that date, unless earlier dissolved in accordance with the provisions of Article VI herein.

# ARTICLE III

# ADDRESS

The mailing address and the street address of the principal office of the Company is 3700 Poinsettia Avenue, West Palm Beach, Florida 33407.

## ARTICLE IV

# INITIAL REGISTERED AGENT

The name and address of the initial Registered Agent of the Company is MARVIN PATEL at 3700 Poinsettia Avenue, West Palm Beach, Florida 33407.

# ARTICLE V

# ADDITIONAL MEMBERS

Additional members may be admitted to the Company only upon the unanimous written consent of all of the then existing Members of the Company, which consent may be unreasonably withheld.

Any individual or entity who is subsequently admitted as a Member shall have all of the rights and obligations of the other

Members.

# ARTICLE VI

# RIGHT OF REMAINING MEMBERS TO CONTINUE BUSINESS

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless all of the remaining Members of the Company unanimously agree to continue the business of the Company.

# ARTICLE VII

# MANAGEMENT

The management of the Company shall be vested in the Members in proportion to their contribution(s) to the capital of the Company.

# REGULATIONS

Prior to dissolution and at least annually as income has been received by the Company, amounts determined and tax returns

filed, the Members shall determine funds available for distribution, in accordance with the ownership interest of each Member. Upon liquidation, a reasonable reserve as mutually determined in amount shall be established as escrows or otherwise, which activity need not unduly delay the termination of the Company for all other purposes. Members shall have no right to demand and receive in-kind distributions.

## ARTICLE X

# INDEMNIFICATION AND LIABILITY

The Company may, as determined by the Members, indemnify and advance expenses to a Member, Manager, employee or agent of the Company in connection with any proceeding to the extent permitted by and in accordance with applicable laws and statutes and Regulations of the Company.

# ARTICLE XI

### AMENDMENTS

The power to amend these Articles of Organization is reserved in the Members of the Company and any such amendment requires the unanimous written consent of all of the Members of the Company.
