## **ARTICLE 1**

### **NAME**

The name of this Limited Liability Company is: HDMG Properties, L.L.C.

## **ARTICLE 2**

### **DURATION**

### CONTINUATION OF BUSINESS

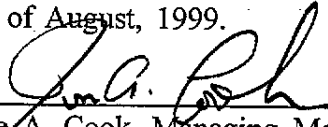

If such person is admitted, he or she shall be subject to the obligations and limitations in the Regulations and Operating Agreement of the limited liability company, as amended for the additional members.

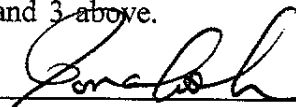

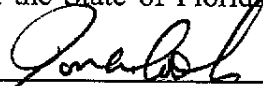
