#### ARTICLES OF ORGANIZATION

#### A Florida Limited Liability Company

#### ARTICLE 1

#### NAME

The name of this Limited Liability Company is: HDMG Restaurants, L.L.C.

#### ARTICLE 2

#### **DURATION**

The duration of this limited liability company is perpetual from the date of commencement of the limited liability company's existence. The date and time of commencement of the limited liability company's existence is the time of filing of the original articles of organization by the Department of State of the State of Florida.

#### ARTICLE 3

#### PRINCIPAL OFFICE AND REGISTERED AGENT

#### CONTINUATION OF BUSINESS

No person may be admitted as an additional member without the unanimous consent of the members. If such person is admitted, he or she shall be subject to the obligations and limitations in the Regulations and Operating Agreement of the limited liability company, as amended for the additional members.
