## ARTICLE I — Name:

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company shall be:

## Article VIII - Regulations

Any Regulations (as defined in Section § 608.402(13) of the Act), relating to this Company must be in writing and signed by all of the Members; however, amendments to the Regulations need only be approved by vote of 75% of the members' interests.

- 2) the total amount of cash contributed by the member(s) is \$5,000;
- 3) if any, the agreed value of property other than cash contributed by member(s) is \$0;
