**ARTICLES OF ORGANIZATION OF
ACCORD ONE GROUP, L.L.C.**

The undersigned organizer and authorized representative of the members, desiring to form a Limited Liability Company pursuant to Chapter 608 of the laws of the State of Florida, The Florida Limited Liability Company Act, hereby certify as follows:

ARTICLE 1 - NAME

The name of the company shall be Accord One Group, L.L.C.

ARTICLE 2 - PRINCIPAL OFFICE

The address of the principal office of the company is 225 Water Street, Suite 1250, Jacksonville, Florida 32202. This is also the mailing address.

ARTICLE 3 - DURATION

The duration of the company shall be perpetual, unless terminated earlier in accordance with the company's regulations.

ARTICLE 4 - INITIAL REGISTERED AGENT AND ADDRESS

The name and mailing address of the company's registered agent for service of process is Douglas D. Chunn, 225 Water Street, Suite 1250, Jacksonville, Florida 32202.

ARTICLE 5 - INITIAL MEMBERS

The initial member of the Company shall be Eric J. Sullivan.

ARTICLE 6 - ADDITIONAL MEMBERS

No member shall have the right to the return of its contribution to capital except as provided in the company's regulations.

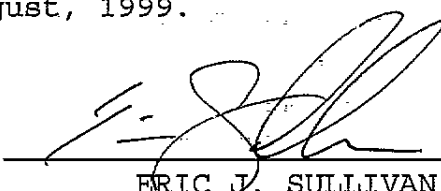
ARTICLE 10 - AMENDMENT OF ARTICLES OF ORGANIZATION

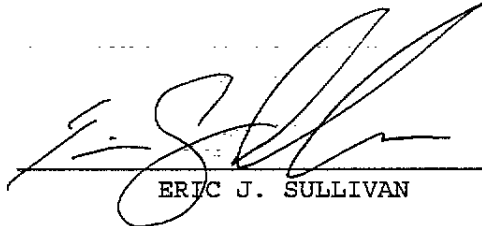
1. The Limited Liability Company to be known as Accord One Group, L.L.C. has one member, who is Eric J. Sullivan.

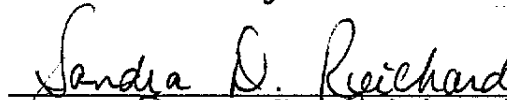
3. The total amount of cash and property contributed and anticipated to be contributed by the members is \$151,000.

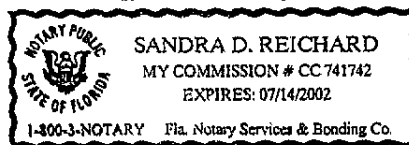
