ARTICLES OF ORGANIZATION

OF

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the "Florida Limited Liability Company Act," do hereby adopt the following Articles of Organization for such company:

- Article 1. Name. The name of this Company shall be GREEN EARTH GARDENS, L.C.
- Article 2. Duration. The period of this Company's duration shall be perpetual, unless terminated earlier by the unanimous written agreement of all Members.
- Article 3. Principal Address. The initial mailing and street address in this state of the principal office of this corporation is 1257 Errol Parkway, Apopka, Florida 32712.
- Article 4. Registered Agent and Office. The name and address of the initial Registered Agent and the address of the principal and registered office for this Company are as follows:

The voting Members shall have voting rights in proportion to their contributions to the capital of the Company, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the voting Members.
