**ARTICLES OF AMENDMENT
TO
OF ARTICLES OF ORGANIZATION
OF DILL & EVANS, LC,
A FLORIDA LIMITED LIABILITY COMPANY**

FIRST: The date of filing the articles of organization was August 31, 1999. An amendment was filed on August 1, 2000.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

1. The introductory paragraph of the Articles is amended as follows:

“The undersigned subscribers to these Articles, being duly licensed to practice law under the laws of the State of Florida, adopt these articles to form a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621 and hereby certify as follows:”


2. Article I of the Articles is amended as follows:

“The name of the limited liability company is: Dill & Evans, P.L.”


3. A new Article VIII is added to the Articles as follows:
