ARTICLES OF ORGANIZATION

OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

- 1. Name: The name of this limited liability company is Grupo Espiral, L.C.
- 2. <u>Duration</u>: The company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

- 7. Management of the Company: The Company shall initially be managed by the following person who shall serve as manager until the first annual meeting of the members or until the successors are elected and qualify:

Thereafter, the Company shall be managed by at least one (1) manager, who shall be elected annually as provided in the regulations.

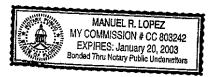
