**ARTICLES OF ORGANIZATION
OF
CAPITAL FINANCIAL MEDIA LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Capital Financial Media LLC (the "Company").

ARTICLE II. PERIOD OF DURATION

The Company shall exist perpetually, unless terminated in accordance with the Company's Regulations or by the unanimous written agreement of the Members.

ARTICLE III. ADDRESS

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE V. RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the membership of a member in the Company, the existence and business of the Company shall be continued by the remaining members without the necessity for the consent or vote of the members.

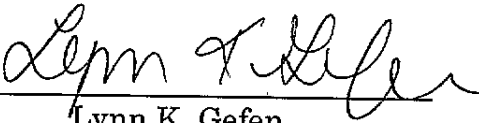
ARTICLE VI. MANAGEMENT

The business of the Company shall be conducted, carried on and managed by no fewer than one Manager, who shall be elected annually by the Members of the Company in the manner prescribed by and provided in the Regulations of the Company. Such Manager shall also have the rights and responsibilities described in the Regulations of the Company. The name and address of the initial Manager is Brian Sodi, 235 Northeast 4th Avenue, Suite 102, Delray Beach, Florida 33483. Such Manager shall serve in such capacity until the first annual meeting of the Members or until its successors are duly elected and qualified.

ARTICLE VII. REGULATIONS

The power to adopt, alter, amend, or repeal the Regulations of the Company shall be vested in the Members of the Company.
