1. Article 1 is amended to read as follows:

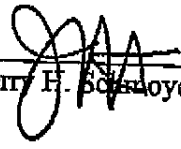
1. **Name.** The name of this limited liability company is **Miromar Outlet West, L.L.C.**, a Florida limited liability company.
