

Following Chapter 608 of the Florida Statutes, the undersigned does hereby submit these Articles of Organization for forming a Florida Limited Liability Company.

**Article 1: Name and Principal Office**

The duration of the limited liability company is perpetual.


**Article 3: Purpose**

## Article 6: Limited Liability Company Operating Agreement

The limited liability company operating agreement regulates the business affairs of this limited liability company.

## Article 7: Transferability of Member's Interests
