ARTICLES OF ORGANIZATION **AVISTA PROPERTIES XI, LLC**

THE UNDERSIGNED, being a member (or a duly authorized representative of a member), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company is AVISTA PROPERTIES XI, the "Company").

ARTICLE II - ADDRESS

ARTICLE IV - MEMBERS

"Members" means the initial members of the Company and also means any additional or substitute members admitted to the Company in accordance with these Articles of Organization and the Regulations of the Company.

ARTICLE V - MANAGEMENT

The business of the Company shall be conducted, carried on and managed by not less than one (1) Manager, who shall be elected by the members of the Company in the manner prescribed by and provided in the Regulations of the Company. Such Managers shall serve in such capacity until the first annual meeting of the members or until their successors are duly elected and qualified.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The admission of additional members to the Company shall require the unanimous approval of the existing members.

ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the

remaining members may continue the Company if all of the remaining members consent in writing to continue the business of the Company within ninety (90) days of the occurrence of an event which would otherwise cause a dissolution of the Company.

ARTICLE VIII - INITIAL REGISTERED AGENT AND OFFICE

The initial street address of the registered office of the Company in the State of Florida is 5353 Conroy Road, Suite 200, Orlando, Florida 32811. The name of the initial registered agent of the Company at that address is ANIL'S VALBH.

ARTICLE IX - PURPOSE

The purposes for which the Company is being formed are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE X - REGULATIONS

The members shall have the power to adopt, alter, amend, or repeal regulations of the Company, containing provisions for the regulation and management of the affairs of the Company.

ARTICLE XI - AFFIDAVIT
