AMENDED AND RESTATED ARTICLES OF ORGANIZATION

I. INTRODUCTORY PARAGRAPH

This Limited Liability Company's present name is SRH MANAGEMENT & OPERATING CO., L.L.C. (the "Company"). The date of filing its original Articles of Organization with the Florida Department of State was September 7, 1999. These Amended and Restated Articles of Organization were duly executed and are being filed in accordance with Section 605.0202, Florida Statutes (2017), and they will be effective upon being filed with the Florida Department of State.

II. NAME

The name of the Company is SRH MANAGEMENT & OPERATING CO., L.L.C.

III. ADDRESS OF PRINCIPAL OFFICE AND PLACE OF EFFECTIVE MANAGEMENT

The mailing address and street address of the principal office and place of effective management of the Company is Calle 13 No. 109 entre 18 y 20, Col. Itzimná, CP 97100, Mérida, Yucatán, México.

The Company shall have the power and authority to establish branch offices at any other place or places where the members may designate, and to change the mailing address and street address of its principal office.

IV. REGISTERED OFFICE AND REGISTERED AGENT

The Company will be a manager-managed company.


