# Articles of Organization of Dos Hombres, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be Dos Hombres, L.L.C. ("company").

# ARTICLE II -- ADDRESS

#### ARTICLE V -- CAPITAL CONTRIBUTIONS

#### ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.


