ARTICLES OF ORGANIZATION OF CONTROL CENTER, L. L.C.

These Articles of Incorporation are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

- 1. Name. The name of this limited liability company is CONTROL CENTER, L. L. C. ("Company").
- 2. Duration. The Company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the event specified in Florida Statutes Chapter 608.441, unless continued by the unanimous consent of all of the remaining members.
- 3. Mailing Address and Street Address. The Company's mailing address is 1013 Montana Street, Orlando, FL 32803-2569.

- 5. Additional Members. Additional member(s) to the Company may be admitted, but only if (all of) the current member(s) agree(s) to the admission of the additional member(s) and to the terms of the admission.
- 6. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining member(s) may, by unanimous written agreement, continue the business of the Company.
- 7. Management of the Company. The Company shall initially be managed by the following three persons who shall serve as managers until the first annual meeting of the members or until their successors are elected and qualify:
