The effective date of this Limited Liability Company shall be the date that these articles are filed with the Florida Department of State.

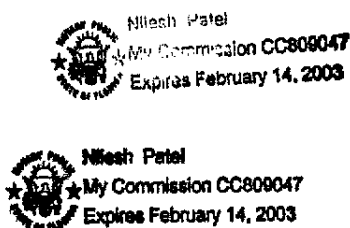

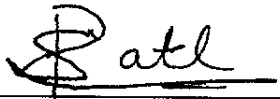
