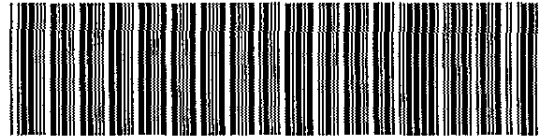

**CERTIFICATE OF AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
CLEARWATER VILLAGE, L.C.**

The Articles of Organization of CLEARWATER VILLAGE, L.C. were originally filed on September 7, 1999, with the Florida Department of State, Tallahassee, Florida. The following amendments to the Articles of Organization were unanimously adopted by the Members at a meeting of the Members on December 28, 2005.

ARTICLE I - Name

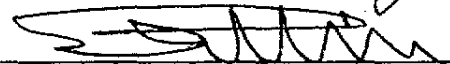
