ARTICLES OF ORGANIZATION OF SUNNYEAR INVESTMENTS, L.L.C.

ARTICLE :

The name of this Limited Liability Company shall be Sunnyear Investments, L.L.C. (the "Company).

ARTICLE II DURATION

ARTICLE VII MANAGEMENT

All business of the Company will be conducted under the exclusive management of its member who will vote according to his proportionate interest in the Company and shall have exclusive authority to act for the Company in all matters.

No additional members shall be admitted to the Company, and no member may transfer his or her interest in the Company, except, in either case as set forth in the Regulations, and if there are no Regulations then in effect, by unanimous consent of all of the members. ARTICLE IX DISSOLUTION AND MEMBERS RIGHTS TO CONTINUE BUSINESS

The Company shall be terminated and dissolved upon:

- (A) the vote of all holding an interest in the Company;
- (B) the expiration of the term of the Company; or
- (C) the death, retirement, or resignation of a member, if the remaining members do not vote unanimously to continue the business of the Company.
