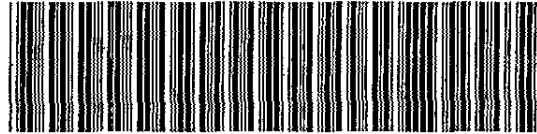

Article 4 .


