

**ARTICLES OF ORGANIZATION  
OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of this Limited Liability Company is The Law Offices of Randy C. Bryan, LLC

**ARTICLE II - MAILING ADDRESS**

**ARTICLE III - DURATION**

The Law Offices of Randy C. Bryan, LLC is to be managed by a manager and the name and address of the person who is to serve as manager is:




