




LIMITED POWER OF ATTORNEY

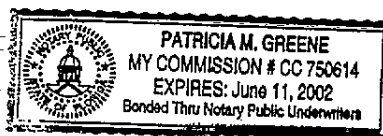


