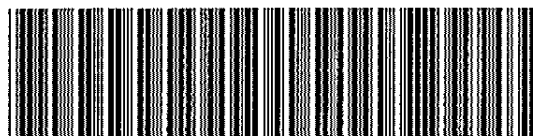

Pursuant to the provisions of Articles s.608.411 and s.608.409(2) of the Florida Limited Liability Company Act, the undersigned limited liability company (the "Company") adopts the following Article of Amendment to its Articles of Organization:

I.

The name of the Company is 2320 South Conway, L.L.C.

II.

The following amendment to the Articles of Organization were adopted by the Members of the Company to be effective October 29, 2004, the full text of such amended section to provide as follows:

7.

INDEBTEDNESS

The Company may only incur (1) indebtedness represented by the mortgage loan for financing of the Property in the amount of \$10,400,000.00 payable to PNC Bank, National Association, its successors and assigns, at an interest rate of 5.13% per annum, with payments of principal and interest based on a thirty (30) year amortization schedule and maturing in ten (10) years (the "Mortgage Loan") and (2) indebtedness represented by trade payables incurred in the ordinary course of business relating to the operation of the Property in its capacity as general partner of the Partnership.

III.

The number of shares of the Company outstanding at the time of such adoption was 100 shares and the number of shares entitled to vote on the amendment was 100 shares.

IV.

The holders of all of the shares outstanding and entitled to vote on the amendment have signed a consent in writing adopting the amendment.




