CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF SEAWAY DECO PLAZA, L.C.

- 1. The effective date of filing of the Articles of Organization was September 13, 1999.
- 2. The following amendments to the Articles of Organization were adopted by the members of SEAWAY DECO PLAZA, L.C. (the "Company") and shall be filed effective September 22, 1999:

ARTICLE
