ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "YARD GOD PRODUCTIONS, LLC."

ARTICLE II — Address:

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any

The remaining members of the Company have the right to continue the business upon the occurrences described in the previous paragraph only if so voted by a majority of the interests of the remaining member(s).

ARTICLE VII — Limitation on Agency Authority of Members

Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

Article VIII - Regulations

Any Regulations (as defined in Section § 608.402(13) of the Act), relating to this Company must be in writing and signed by all of the Members; however, amendments to the Regulations need only be approved by vote of 75% of the members' interests.
