AMENDED AND RESTATED ARTICLES OF ORGANIZATION
FOR FLORIDA
LIMITED LIABILITY COMPANY

Pursuant to the provisions of Section 608.411, Florida Statutes, The PDP Group, LLC hereby amends and Restates its Articles of Organization by deleting the articles currently filed and substituting the following:

ARTICLE I – Name

The name of the Limited Liability Company is The PDP Group, LLC.

ARTICLE II – Address

The mailing address and, if different, the street address of the principal office of the Limited Liability Company, which may be amended from time to time, is:

ARTICLE III – Existence and Duration

The Limited Liability Company commenced existence on September 16, 1999, the date that Articles of Organization were originally filed with the Secretary of State. The duration of the Limited Liability Company is perpetual.

ARTICLE IV – Management

The Limited Liability Company is to be managed by the members and is, therefore, a member managed company. The only managing member is PDP Nevada II, Inc.

ARTICLE V – Member's Rights to Continue Business

Subject to the unanimous approval of the remaining members of the Limited Liability Company, The PDP Group, LLC may continue its business on the death, retirement, resignation, expulsion, bankruptcy, withdrawal or dissolution of a member or the occurrence of any event that would otherwise terminate the business or cause the dissolution and winding up of The PDP Group, LLC, notwithstanding Section 608.427 or any other provision under the Florida Limited Liability Company Act, as may be amended from time to time.
