ARTICLES OF ORGANIZATION OF EPORIUM, LL.C.

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

NAME. Ì.

The name of the Limited Liability Company is:

E.PORIUM, L.L.C. PERIOD OF DURATION. 2.

The period of duration of the Limited Liability Company shall be from the date of filing until the first to occur of the following:

- Ninety (90) years from the date of filing of these Articles of Organization with 81. the Department of State, or

PURPOSE. 3.

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. 6. CAPITAL CONTRIBUTIONS.

The total amount of each and a description of the agreed value of property other than each contributed to the Limited Liability Company is as follows: \$1,000 in each and no other property is being contributed to the Limited Liability Company at this time.

ADDITIONAL CONTRIBUTIONS.

The total additional contributions, if any, agreed to be made by all members and the times at which, or the events of happening of which, that shall be made, are as follows: No total additional contributions have been agreed to at the date of filing of these Articles of Organization. Additional contributions, if any, will be made in each or by the contribution of property at such value as shall be approved by the Managers. 8. CONTINUITY OF BUSINESS.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall not be continued and the Limited Liability Company shall be dissolved unless there is obtained the consent of all the remaining members of the Limited Liability Company.

MANAGEMENT.

The Limited Liability Company is to be managed by a manager, or managers. Names and addresses of such managers who are to serve as managers until the first annual meeting of mambers or until their successors are elected and qualified are as follows:

10. MANAGEMENT.

Company's activities, including the power to sell all or substantially all of the Company's assets, shall be reserved to one or more Managers, each of whom shall be a Member and shall serve in such capacity for a period of one year beginning with the formation of the Company. Thereafter, the Managers shall continue on a year to year basis as managers of the Company's affairs unless replaced with other Members by a vote of eighty percent in ownership interest in the Company at the annual meeting of the Company as set forth in the Company's Regulations. The Managers may also be

replaced with other Members at any time by a vote of ninety percent in ownership interest in the Company.

b. The power to dissolve the Company shall be reserved to seventy-five percent in ownership interest of the Members.
