Each manager of the Company executed these Articles of Dissolution on the date shown below.

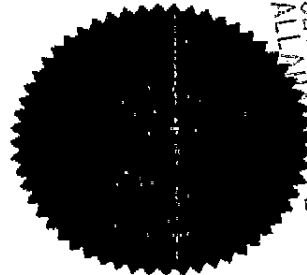
