ARTICLES OF ORGANIZATION OF HARBOR WATCH, L.L.C.

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I NAME The name of the limited liability company, hereinafter referred to in these Applicles as "Company," Harbor Watch, L.L.C. ARTICLE II ADDRESS ARTICLE II ADDRESS

ARTICLE IV PURPOSE

The general purpose for which the Company is organized is to develop and construct condominium projects.
