Article I Name

Article V Share Certificates

(a) <u>Board of Managers.</u> This company shall be managed by a Board of Managers or Directors. There shall initially be two (2) Managers. The number of Managers may be increased or decreased, as provided in the Company's Regulation and Operating Agreement.
