**ARTICLES OF ORGANIZATION

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is ENTOMOS, L.L.C. (the "Company").

The Company will be managed by the Board of Managers of the Company in accordance with the Company's regulations. The name and business address of the initial managers are as follows:




