(A Florida Limited Liability Company)

**FIRST:** The date of filing of the articles of organization was September 30, 1999.

**SECOND:** The following amendment(s) to the articles of organization was/were adopted by the limited liability company:

The limited liability company is to be managed by one (1) manager, and is therefore a manager-managed limited liability company.
