

ARTICLES OF ORGANIZATION OF RENAL HOME SUPPLY, LLC

The members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I NAME OF COMPANY

The name of the limited liability company is Renal Home Supply, LLC (the "Company").

ARTICLE II PERIOD OF DURATION

The Company shall terminate on December 31, 2025.

ARTICLE III REGISTERED OFFICE AND AGENT

The address of the Company's principal office is 600 Cleveland Street, Suite 910, Clearwater, FL, 33755. The name and address of the Company's initial registered agent are Elise K. Winters, 600 Cleveland Street, Suite 940, Clearwater, FL 33755.

ARTICLE IV ADMISSION OF ADDITIONAL MEMBERS

Additional persons may be admitted to the Company as members and membership interests may be created and issued only as provided in the Company's Operating Agreement.

ARTICLE V DISSOLUTION

The Company shall be dissolved upon the first to occur of the following:

- (a) The expiration of the term of the Company;
- (b) The unanimous written consent of all the Company's members;
- (c) The death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company;

unless within ninety (90) days after such event a majority in interest of all the remaining members agree in writing to continue the business of the Company.


ARTICLE VI


