# ARTICLES OF ORGANIZATION OF RENAL HOME SUPPLY, LLC

The members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

# ARTICLE I

### NAME OF COMPANY
