First: The name of the limited liability company is TowerCom Mid-States, LLC

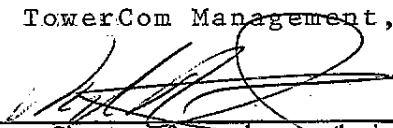

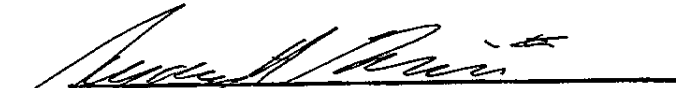
