**ARTICLES OF ORGANIZATION OF
PRO LEGAL COPIES, L.L.C.**

The undersigned, MICHAEL P. CANNON, a natural person competent to contract, hereby present these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is:

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the principal office of the limited liability company is 220 West Garden Street, SunTrust Building, Suite 206, Pensacola, Florida 32501.

Except where a Member has received a bona fide offer to purchase a Member's Membership Interest, the offer has been offered to the limited liability company and/or other Members of the limited liability company, and the company and the Members declined to purchase the Membership Interest on the terms offered by the third party, the decision to admit a new Member into this company, or to allow a Member to sell, assign, gratuitously transfer, devise or otherwise transfer (with or without consideration) his or her Membership Interest shall require the unanimous consent of the Members. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS

The term of the business shall be that set forth in Article IV herein, and it shall not be affected by the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company.

ARTICLE X - RESTRICTION ON MEMBERSHIP

A member's interest in this company is subject to the restrictions set forth in Article VIII above.

ARTICLE XI - COMMENCEMENT OF EXISTENCE


The date for commencement of the limited liability company's existence shall be the date these Articles are filed with the Florida Secretary of State.

ARTICLE XII - AMENDMENT

The company reserves the right to amend these Articles of Organization or any amendment thereto from time to time by the Members in accordance with the Florida Limited Liability Company Act.
