**ARTICLES OF ORGANIZATION
OF
KAMJO PROPERTIES, L.L.C.**

The undersigned adopt the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608:

ARTICLE I – Name:

The name of the limited liability company (hereinafter referred to as “Company”) is:





To arrive at the Point of Beginning; Commence at the East quarter corner of Section 35, Township 24 South, Range 36 East, Brevard County, Florida, proceed westerly along the North line of the SE $\frac{1}{4}$ said Section 35, South 89°6'35" West, 1034.92 feet to the intersection of the South line of a 50 foot roadway and the East line of Imperial Street; thence Southerly with said East right of way line, South 00°32'15" East, 227.03 feet to the Point of Beginning; thence for a first course run easterly parallel to the aforementioned North line of the SE $\frac{1}{4}$, North 89°6'35" East, 650 feet; thence for a second course run Southerly and parallel to the aforementioned East right of way line of Imperial Street, South 00°32'15" East, 230 feet to the North line of Bel Aire Subdivision Unit Two as recorded in Plat Book 17, page 50; thence for a third course run Westerly with said northline South 89°6'35" West, 650 feet to the aforementioned East right of way line of Imperial Street; thence for a fourth course run Northerly with said East right of way line, North 00°32'15" West, 280 feet to the point of beginning.
