**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **UNIVERCELL TELECOMMUNICATION SYSTEMS, L.L.C.**, ("Company").

**ARTICLE 2 - ADDRESS**




