**LIMITED LIABILITY COMPANY POWERS**

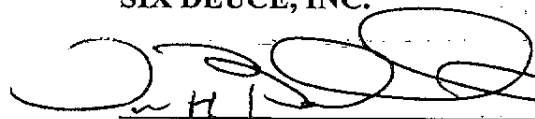
